## TAVUK DÜNYASI GIDA SANAYİ VE TİCARET ANONİM ŞİRKETİ (DÜRÜMLE) INFORMATION NOTICE ON THE PROTECTION AND PROCESSING OF PERSONAL DATA

### 1. General Definition

The Law on the Protection of Personal Data No. 6698 (“**Law**”) sets forth the procedures and principles to be followed by natural and legal persons regarding the protection of fundamental rights and freedoms and the processing of personal data. Within the scope of the Law, personal data includes any kind of information relating to an identified or identifiable natural person. A special category of personal data, namely sensitive personal data, refers to data concerning race, ethnic origin, political opinion, philosophical belief, religion, sect, other beliefs, attire and dress, association, foundation or union membership, health, sexual life, criminal convictions and security measures, as well as biometric and genetic data.

This text is presented to you by our company, **Tavuk Dünyası Gıda Sanayi ve Ticaret Anonim Şirketi** (hereinafter referred to as “**Dürümle**”) in relation to Dürümle-branded products and services. This text has been prepared by Dürümle, in its capacity as data controller, in order to fulfill the obligation to inform the relevant individuals at the time personal data is obtained, pursuant to Article 10 of the Law.

### 2. Data Controller

Dürümle attaches great importance to the processing of personal data in all its activities and aims to fulfill all its obligations under the Law on the Protection of Personal Data No. 6698 and related regulations.

In this context, your personal data may be processed, in accordance with the Law, by **Tavuk Dünyası Gıda Sanayi ve Ticaret Anonim Şirketi**, located at **Aydınevler Mah. Sıteleryolu Sok. Hilltown AVM No:1 A/5 Maltepe/İstanbul**, in its capacity as data controller, for the purposes listed below, and in connection with, limited to, and proportionate to such purposes, while maintaining the accuracy and currency of the personal data as it has been provided to us, within the scope described below.

## 5. Method and Legal Basis for Collecting Your Personal Data

Your personal data may be collected by Dürümle, based on the legal grounds set forth in Articles 5 and 6 of the Law and detailed above, as well as with your explicit consent in certain processes. Data may be collected physically through direct submission, or electronically via email, the company's website, publicly available internet sources, social media, phone, and SMS channels, or physically through in-person delivery and postal services.

## 6. Your Rights as a Data Subject under Article 11 of the Law

Pursuant to Article 11 of the Law, we inform you that as data subjects, you have the following rights:

- > To learn whether your personal data is being processed,
- > To request information if your personal data has been processed,
- > To learn the purpose of processing your personal data and whether it is being used in line with such purposes,
- > To know the third parties, domestic or abroad, to whom your personal data has been transferred,
- > To request the correction of your personal data if it is incomplete or incorrectly processed, and to request that the third parties to whom the data has been transferred be informed of such correction,
- > To request the deletion or destruction of your personal data if the reasons for its processing no longer exist, even though it has been processed in accordance with the Law and other relevant laws, and to request that the third parties to whom the data has been transferred be informed of such deletion or destruction,
- > To object to the occurrence of a result against you by analyzing the processed data exclusively through automated systems,
- > To request compensation if you suffer damage due to unlawful processing of your personal data.

For requests regarding the rights listed above, you may submit a written and signed petition that meets the minimum requirements set forth in the "Communiqué on the Procedures and Principles of Application to the Data Controller."
